CONFERENCE MINUTES

All the various groups mentioned on the previous page held their own annual conferences and minutes were printed in annual volumes, which also include biographies of ministers, recently deceased, and prominent laymen, and women. Hill's 'Alphabetical arrangement' contains a list of all deceased ministers with their date of death, so a check of the relevant minutes for that year or the year preceding should reveal the biography. This only applies for Wesleyan ministers. For Bible Christian, United Methodist Free, or Methodist New Connexion ministers, a check should be made of Beckerlegge, O.A. United Methodist Ministers & their circuits (1968) For Primitive Methodists, the index compiled by William Leary on similar lines is available in typescript at the Methodist Research Centre.

PREACHING PLANS

Information can be obtained from preaching plans, which were issued by all groups, usually quarterly. Many plans of the smaller groups, e.g. Wesleyan Methodist Association, New Connexion, are very rare. Information with regard to plans may be obtained from the secretary of the Cirplanological Society, Mr. E.A. Rose, 26, Roe Cross Green, Mottram, Hyde, Cheshire. The largest collection of circuit plans is at the Methodist Archives Centre, see previous page.

REGISTERS

Many Methodist registers were surrendered in the 19th century and are now in the Public Record Office in London, though many were not. Those that survive should be in the hands of the circuit safe, in the main church of the circuit, though as there has been so much change in the circuit boundaries they may well be found in local record offices.

MARRIAGE: 1805 Nov. 17th. Wm. BILLENGE widr. and Hannah WHEELDON, at ALSTONFIELD, Staffs. Wm. BILLENGE aged 85, to Miss Hannah WHEELDON aged 15. The happy couple on that morning walked fifteen miles in three hours and half.

"A very strong and fiery Meteor in form like a sword appeared North-west by West in December 1680 and continued about 6 weeks, after which ensued a tedious and long Drought which began April the 10th 1681, and continued till June 20th the same year, Which (as thewisest thought) procurred many pestilentous diseases as agues, strong ffeavours, smallpox,cum multis aliis, of which many died in ye countrey, chifely in great cities and towns corporate.

## THE LEGEND OF ALFRED NEWTON SPENCER.

When I was a small child I was fascinated by a story often told me by my grandmother, Elizabeth (Spencer) Allsopp. It concerned her brother, Alfred Newton Spencer. As I recall, Grandmother said that her brother had gone into the town of Derby, England, to have lunch with a friend. In the middle of lunch, Alfred excused himself, left the restaurant, and was never seen again. Alfred had no children, and thus, vast sums of money were tied up in the English courts waiting for someone to prove Alfred dead so that the money might be distributed to the families of Alfred's sisters.

The story changed slightly over the years. There was a rumour that Alfred had been seen in Canada. And, my Aunt told me, I remembered the story wrong... Alfred had made an appointment for lunch with a friend at the Bull Hotel in Derby, and had never kept the appointment.

When, in my adult life, genealogy became my pusuit, I hoped I might find some clues to just what did happen to Alfred. Success came through the use of many civil registration records, parish records and the assistance of genealogists with legal backgrounds. But, most important, was meeting with one of Alfred Newton Spencer's grandchildren, Mrs. Marjorie Edmands, of Mickleover, Derbyshire, England. This was arranged by a newly-discovered Allsopp relative. Now, most of the mystery surrounding this legend has been solved.

Alfred Newton Spencer was born October 29, 1859 at the Spout Farm, Ashley hay, near Wirksworth, Derbyshire. He was the only son of William and Mary Ann (Gough) Spencer. Alfred had three sisters, Elizabeth, four years his senior, Emily, three years his junior, and Ethel, nearly sixteen years younger. His father, William, was a dairy farmer and land owner of excellent reputation in the Midlands, winning the "Finest Farm in the Area" award in 1855.

After leaving Spout Farm, the family resided at Offcote House near Ashbourne, eventually moving to Kirk Langley, near Derby. Alfred was a sensative person, more inclined to the arts and sketching than to farming. Being an only son, he was somewhat of a mother's favourite, and his lack of enthusiasm for farming was not severely criticized.

In about 1883 Alfred Newton married Catherine Ann Osborne, (Kate), whose brother, Thomas Osborne, became the husband of Alfred's sister, Emily. The Osbornes were local people, Kate was born at the Snapes Farm, Kirk Langley, Way 10 1860. Alfred and Kate moved in with Alfred's parents at Buck Hazels Farm in Kirk Langley. There in her "in-laws" home, Kate bore four children, Alfred Edward, b. 1882; Nelly, b. 1886; Sidney, b. 1890; and Everard, b. 1892. Evidently, during this period, some antagonism existed between Kate and her mother-in-law, and she nagged. Alfred to give up the sketch pad, settle down to farming, and find them a home of their own.

Meanwhile, Thomas Osborne and his wife, Emily (Spencer) Osborne, had given up farming to run "The Summer House" at Gospel End, Sedgley. They then made a decision to move to Canada, and while preparing for this move, lived at Lutterworth, Leicestershire.

After the death of his father, (1891), and after the birth of his fourth child, the living situation at Buck Hazels Farm became more tense. Thus, on July 3, 1893, following another argument with Kate over the housing situation, Alfred walked out, saying, "Alright, Kate, I'll find us another place." This was the last that Kate or the children ever saw of Alfred, Kate retold this tale each July 3 from then on.

Some weeks later, Alfred appeared at his sister's home in Lutterworth. He said that he was looking for a place to live, and was trying to decide what to do. He left them shortly thereafter.

When Alfred failed to return, Kate's plight grew more serious. She packed up the children and left Buck Hazels Farm, moving back to her sister Mary Lockett's home, The Snapes Farm, where she stayed for a short time. Then Kate moved on to The Burrows in Brailsford, where she was able to rent a small cottage. Here she took in sewing and other types of work to enable her to keep her family together.

Kate's life had other tribulations. She raised her four children, and then, because of early death in 1917 of her oldest son's wife, Kate raised three grand-children, Florence Marjorie (now Mrs. John Edmunds) who was born about 1913, and Barbara (Mrs. Wilfred Foster of Derby) and Alfred Arthur, who died in 1971.

What about the rumoured "fortune" waiting to be distributed? This fortune came from the estate of George Gough, Alfred's grandfather, who died in 1874. George Gough directed in his will, a copy of which is in my possession, that after certain specific bequests to his children, the bulk of his estate should go to his wife, and at the time of her decease, (1879), it should be divided equally among his children. However, should his son, William Gough, who had gone to New Zealand, not return within five years to claim his inheritance, that share should be divided between the three remaining children. This would be in 1884. I do not understand why grandchildren would figure in this distribution, as Alfred's mother was still alive in 1884. However, the distribution papers definitely state that this was "The amount received from The Trustees of George Gough deceased representing the Capital monies and accumulated income due to the Estate of Alfred Newton Spencer deceased." In light of this I felt that Alfred's sisters should have figured in similar bequests, which I later found to be the case. I look back now on the remarks made when I first heard of this legend, and I assume that my grandmother, not realising that Alfred did have descendants, was concerned over the distribution of that share marked for Alfred.

Alfred's children matured and realising he would never return, were anxious to settle their father's affairs. A son of Thomas and Emily Osborne had an unusual experience during the World War I years in Canada. He was approached by a military officer who asked him many questions about his relatives in Derbyshire. Finally the young man said, "Sir, you seem to know my family, but I don't know who you are." "That doesn't matter, does it?" said the officer, and walked away. The young man returned home and said, "Mother, I think I have seen Uncle Alfred." This story, of course, had been reported back to Alfred's family.

In the late 1930's, Alfred's son, Everard, started the legal wheels rolling to rule on the outcome of Alfred's estate, In 1938 the Probate Court of Kirk Langley declared Alfred dead, giving due and proper notice, in the legal columns of the papers.

Everard Spencer passed away in 1939, Distribution of the estate was made in 1941 by the law firm of Cottrell & Son, two-fifth share to Mrs. C.A. Spencer, and one-fifth share each to Alfred Edward Spencer, Sidney Spencer, and Mrs. Nellie (Spencer) Clarke. This "Fabulous Fortune" was quite modest...a total of £789.

In later years, Kate told her children and grandchildren that she believed Alfred had died at the Chicago Fair. (World's Fair in Chicago in 1933). Why Kate believed this, whether she had some real information, I do not know.

Poor Kate did not live long after the final settlement of this heartbreaking affair. She passed away January 3, 1944 at the age of 84, at Nunsfield Cottage, Long Lane, and is buried in the Long Lane Church Yard near Dalbury, Derbyshire.

Alfred Edward died in 1954, Sidney in 1966, but Mrs. Nellie Clarke, daughter of Alfred and Kate is still living, and resides in Escondido, California.

Other tales surround this sad story, but I feel they are the typical tales of human frailties and need not be mentioned. I have enjoyed meeting one of Alfred's descendants, and finding that Alfred and Kate have many living grandchildren...my second cousins. I hope to become acquainted with more of them. The fun of sleuthing, exploring, and meeting wonderful people has been worth far more than £700!

# MEMORIAL INSCRIPTIONS OF ST. JOHN THE BAPTIST CHURCH, BOYLESTONE.

Recorded by Sandra Tomkinson.

"Here came a company of Cromwell's men in the night, dismounting from their horses and silently surrounding the church that stands so high above the sunken lane. They waited for the peep of dawn to call upon the enemy to surrender. Indoors were 200 Cavaliers sheltering for the night on their way to the relief of Windfield Manor. They had set no watch outside the church and so were caught in a trap of their own setting. One by one they came through the priest's doorway and were taken and stripped of their arms. Men, colours and all without the loss of one man on either side."

An avenue of stately limes has grown along the way the soldiers must have trod, bringing us to the church whose tower with odd peaked roof is barely a century old. It is snow white indoors save for the grey walls of the chancel and the nave arcade. Its oldest stones are in the 13th Century buttresses of the chancel, the rest of the church having been made new in the 14th Century, perhaps by Walter de Waldeshef who was chief butler to the King, and Governor of the Castle and Honour of the Peak; but the east window is a century later, and some are new, as in the chancel arch. The font is 600 years old. There is still the priest's doorway through which the Cavaliers walked out to meet their captors: and there are still oak tie beams and bosses in the roof.

The last supper is finely carved above the alter, with a background of little squares of diaper work, about 120 of them no two quite alike.

## PLYMOUTH CONFERENCE Sept 1979.

Following my half yearly "custom" I travelled to Plymouth to attend the Federation Conference. It was a long way to go but both Mrs. Stumbles and I were able to "kill 2 birds with one stone" and while I stayed with relatives in Hants in order to visit Winchester Record Office, Mrs. Stumbles took the opportunity to look at records in Plymouth for her personal researches.

The College of St. Mark and St. John was an excellent venue for the Conference but was very difficult of access for those without their own transport, so much so that, while others attended the banquet, vegetarian Mary and colleague Mrs. Stumbles sat in their room eating ginger biscuits and tomatoes and sorting marriage index cards presented by Judy Warren. Such are the trials and tribulations of the vegetarian genealogist!

The programme of lectures for the week-end was most interesting and varied. Mrs. Rowe prepared an informative and practical talk on Records in Devon before Parish Records but unfortunately her talk was marred by the recalcitrant behaviour of the slide projector. However we were able to learn a lot about the muniments of the landed gentry, "the things by which you guarded your title etc", and about the importance of the manor and court rolls available at the Devon Record Office.

Professor Norman Pounds then spoke on the value of demography to the family historian and stressed the importance of the various Muster Rolls, Hearth taxes and Poll taxes. We even learned that all but the poor and the clergy in 1377 paid 1 groat in tax to the King.

In the afternoon our own Colin Chapman assured us by slides and persuasion that "Heraldry  $\underline{\text{CAN}}$  be understood" and after such a fine lecture everyone should agree that it is certainly true.

This was followed by a lively question and answer session when all the lecturers were bombarded with questions and answers but the time was all too short, as always, to get in all the answers required.

The Council meeting on Sunday opened on a very sad note when we stood for a minute's silence for Lord Mountbatten, formerly President of the Society of Genealogists, and many members must have been remembering his exhibits which were included in Heffer's exhibition at Cambridge.

There followed detailed reports by members of the committee. The Chairman stressed that the function of the Federation was, not to control but to serve

member societies and to make friendly contact with organisations who might help in improving facilities for research. John Rayment appealed for all those who have completed any projects to send in the details for inclusion in an up-to-date catalogue.

It was agreed that we should honour Elizabeth Simpson, who has made such a great contribution to the success of both the Federation and individual Societies, by founding an award in her name for the magazine judged to have made the most significant contribution to the "cause" of Family History.
