

EDITORIAL

The beginning of 1979 brought an interesting discovery to the Society. Mr. Fred Hall found in the Local Studies Dept. at Derby Library, a register of Births (not baptisms) for Ripley 1753-1805. These were recorded by a dissenting minister Judah Jagger and contains many names from surrounding villages, including Denby, Heage Codnor, Loscoe, Lea, Ashover, and Swanwick. A note accompanying the register reveals it has twice been sold, once in 1846 for the sum of 4 shillings and again in 1881 for 10 shillings! It has now found a safe home, although, ideally, shouldn't it be at the Record Office Matlock, where other registers are kept? Photocopies of the register will shortly be available in our Society Library.

Recently, our Secretary was handed the register of Banns of Marriage 1852-1887 belonging to Pentrich Parish Church. This was rescued several years ago from a dust bin and had been in private hands ever since. The register has now been returned to the church by our Secretary with a strong recommendation that it be placed into the care of the Record Office. The present vicar was delighted to receive it back, but said that the church had very adequate provisions for the keeping of registers. Before the register was returned to the church it was transcribed by Mrs Joan Smedley, providing another valuable addition to our Society Library.

How many more registers are there in private hands and how many have been destroyed? The fate which would surely have befallen the Pentrich Banns Register if it had not been noticed amongst the rubbish. Under the Parochial and Records Measure which has now become law, those parishes which have not already deposited their records at the Record Office will be required in due course, to do so. At the moment, exceptions are made where stringent provisions are made in respect of the storage of these documents.

At the December meeting, the question of Auditor was discussed and no objection to the appointment of a Society member was raised. I should like to thank Mr. Peter Whitlam for offering his services as Auditor, which the meeting gratefully accepted. Many thanks go to Anna Crill of California and Mrs G. Wheatcroft of Solihull who have both sent many page manuscripts about their family history to the Society. Many thanks also to those who have sent in articles for "Branch News", some already published and others yet to appear.

Hutton, the noted Derbyshire Historian, gives this account. "Noah Bullock had thre sons, Shem, Ham, and Japheth, baptised in 1670, 1672 and in 1681. Noah built an Ark on the Derwent and resided there, carrying on his business of coiner of false money."

FOUNDLINGS

In answer to the query about the burial at Ashbourne of children from the foundling hospital in London (in Strays of Branch News no. 4), our member Mr. W.R. Thorp writes ;-

"If anyone finds difficulty in finding an ancestor, and the baptism and other members of the family such as brothers and sisters, cannot be found, there is always the possibility the child was a foundling.

Very often these were illegitimate children who were in the care of these institutions. The Foundling Hospital in London sent children of a tender age out for "nursing". These babies were sent to many parts of the country in wagon loads.

These pathetic human cargoes would also include a number of children of perhaps eight or nine years of age who were to be apprenticed, or work in mills, and little girls to go into domestic service. The children at the London Foundling Hospital were given numbers. It sounds just like prisoners or of being in the Armed Forces.

One can only imagine what a terrible experience it was for these poor little things to be sent on such a journey, which to them would be like the other end of the world. At the end what fate awaited them? Some of those poor little girls became domestic drudges and died very young. Boys were worked to death and some were killed in accidents. Many succumbed to disease.

A few survived and grew up to marry and have their own families. Paul Campbell, no. 2979, and Alice Turner, no. 2323 were two such children who were sent out by the Hospital either as babies, or if older, to work at Ashbourne. I wonder if there is any tombstone for them in Ashbourne Churchyard.

At Otley Parish Church in West Yorkshire I have seen a tombstone over the grave of five children who had been sent out like the above, to work in a mill at Burley-in- Wharfedale. These five children died between the ages of eleven and fourteen.

Now to a rather important side of the story. If a member suspects one of their ancestors was a foundling they will find tracing them difficult.

The Thomas Coram Foundation used to hold all the records for the London Foundling Hospital, but a few years ago these records were placed with the Greater London Council.

I possess some old deeds relating to two lots of copyhold property at Bolsover. This land belonged to my grandfather, JOSEPH HARRY COUSIN, who had inherited it in 1902 from his father, WILLIAM COUSIN, a grocer and and druggist in the town. Quite a large number of names are included in the documents and I have listed them below in the hope that someone may find them useful.

CODNOR and LOSCOE were, until recent years two mining villages, lying between HEANOR and RIPLEY. The collieries are now closed. The parish of Codnor along with Loscoe was formed in 1844 from the parishes of Denby, Heanor and Pentrich. The church, dedicated to St. James, was erected in 1844 on the hill midway between the two village The Butterley Company opened collieries in the area in 1824, where the majority of th inhabitants worked, until mining in the area ceased with the closure of Ormonde Colli at Loscoe in 1970. A number of men worked at the Codnor Park Blast Furnaces 2 miles away, also owned by the Butterley Company, these too, are no longer in operation. Framework Knitting was also a form of employment and a few worked on the land.

LOSCOE became a separate parish in 1927. The church (now the church hall) was built on land given by the Butterley Company who also contributed to its erection. Later, in 1938, St. Luke's church was built, a gift of James John Arthur Woolley, Esq. of Egreaves House, and friends. The baptist chapel dates from 1722, recorded by a date stone which also bears the initials F.T. believed to be those of Francis Tantum. John Hieron, ejected rector of Breadsall, brought non-conformity to Loscoe and died here in 1682. A well known personality, Mr. John Gillott, lived in the cottage by the dam, where he worked as a framework knitter. His stocking knitting frame, which sto until recent years in the cottage, was given by his daughter, Miss Mary Gillott, to Aristoc factory as a museum piece. It is now at the F.W.K's museum at Ruddington. Loscoe had a small Brickworks owned in 1922 by Owen Smedley and by the Gaunt family afterwards for many years until it closed in 1975.

The Ruins of Codnor Castle.

The castle, formerly standing in a park covering an area of 3,300 acres, was founded by William de Peveril, son of the Conqueror and remained in the hands of the Peverils until 1154. All the estates connected with Codnor then came into the hands of the Greys and afterwards the Zouch family. These families, as mentioned in "Branch News" no. 7, became Lords of the Manor. After passing through several hands, the estate was bought by Sir S. Masters in 1712 and in 1861 it became the property of the Butterley Company. The castle is now in a very ruinous state, a number of farmhouses in the district having been built with stone from it.

Charities: Money was left for the poor of Codnor and Loscoe by Jonathan TANTUM in 1705 and by the Rev. Francis GISBORNE of Staveley.

CODNOR BREACH: An ancient house, the property and residence of Mr. Joseph GRAMMER, is one of the finest situations in the neighbourhood and commands an extensive prospect over the surrounding country. Near to the house there is a Quaker Chapel and graveyard. (Glover)

Thomas HOWITT of The Dene, and Pheobe TANTUM of The Falls were married at the Friends Meeting House at Codnor Breach in 1790. They became the parents of William HOWITT the poet in 1792. In about 1908 I was taken by my parents to see a very big gathering of

Quakers from all over the world at the Friends Graveyard at Denby Common Broach.

The other members of the Grammer family I have recorded, are in 1830. Grammer, a carrier of goods from Heanor to Nottingham, - Wednesdays and Saturdays, return the same day. In 1840 Clayton Richard Grammer Esq. described as a farmer and colliery owner resided at Millhay. I believe the Clayton and Grammer families were related.

"All in the Family" - another success story.

Our Californian member Marie Ortmann had for some time been trying to find her JEPSON relatives in BLACKBURN and at that distance it seemed so simple for one of us just to nip over to Blackburn after tea to find out what had happened to "the cycling Jepsons" who, as far as she knew, were still in business as cycle manufacturers early this century.

As I could not hope for an early opportunity of visiting Blackburn I wrote to the Lancashire Evening Telegraph and after the editor published my letter, free of charge, the response was overwhelming, especially that from the actual family themselves who now run "the largest furniture business in the North".

But read on in Arnold Jepson's own words from the 11 page letter he wrote to me.

"I'm the youngest son of R.L. Jepson who founded the business known as R.L. Jepson Ltd. Cycle manufacturers of 19, Northgate, Blackburn. I think undoubtedly we are the firm to which Mrs. Ortmann refers and we are still in existance. The Business was established in 1870 by R.L. Jepson who left school at 9, became a telegram boy, then a postman and at the age of 20 he started his business with £16 being the proceeds of his Christmas tips. He went into partnership with a Birmingham man called T. Cemm initially. The Partnership didn't last long although T. Cemm continued to work in the firm until about 1937 as a paid employee of R.L. Jepson. The firm had two other retail shops by this time, one in Lancaster and one in Kendal, the Lancaster one being manage by my mother Janet Jepson, whilst Father continued the business in Blackburn.

About the turn of the century the firm moved to 19, Mincing Lane and started wholesaling cycle components, car components and tyres. R.L.J. was firstly a very keen cyclist. He used to race round the Blackburn kovers football ground and was the first person to ride up a well-known hill in Blackburn called Steep Brow. At this time he also became very much a pioneer motorist, starting in the early days of motoring with a Riley Tri-car - De Dion Bouton - Humbrette - Phoenix. In 1920 he was the proud owner of a Vauxhall 23/60 tourer. During World War I he escaped call-up, I think because of ill-health, but continued to develop the business.

In 1919 he bought a 16 acre farm called "Throstle Nest", Saccary Lane, Mellor, near Blackburn, and converted the house into a very nice dwelling and started a home farm.

In 1926 when radio was becoming popular he ventured into this business, selling wholesale kits of parts for amateurs to construct their own receivers. In 1929 he bought a large cotton mill for £300 called Nova Scotia Mill, Rayth, Blackburn. This was during the slump and most people thought he was crazy to do this. However he had tremendous vision and courage - his aim was to see his varied enterprises then dotted around Blackburn all assembled under one roof. In 1933 my eldest sister and brother were starting to set up home and my father never liked buying anything retail if he could help it. He approached a firm of furniture manufacturers in Burnley and bought 6 bedroom suites from them. My brother and sister had their choice from these and the remainder were left in the cycle shop. The customers said they would like to buy them and so began a new shift.

He had lots of unused space in the mill, so he started in the furniture trade. Within a space of 2 years this built up so rapidly that the sales overtook the rest of the business. Very soon he created one of the largest furniture stores in the North England, selling furniture and carpets. His next venture was furniture manufacturing. He didn't like the standard and quality of upholstery that he could buy so he started his own upholstery manufacturing business.

Then came World War II. Practically the whole of the stocks were sold and could not be replaced. With the surplus money he bought about 6 hill farms from the Hornby estate near Lancaster. The mill was then used for food storage as a buffer depot for the Ministry of Food. After the war, normal goods were scarce, so he bought very heavily, Government Surplus Stores and with his usual determination made a great success of this.

I was demobilised in February 1946 and started to rebuild the furniture dept. from scratch and this still flourishes. R.L.Jepson died of cancer in 1953 at the age of 79. He was still as active in business up till the day he died as he had always been. From his hospital bed he used to ring up daily to see how various deals were progressing.

From then on the business continued to prosper. We had all been brought up in a hard school and all of us started doing useful work from the age of 9 or 10. The family consisted as follows; - Kate Audrey Jepson born 1900 (now Isherwood)
Rona Jepson born about 1905, died from pneumonia at 6 mths. Sidney Jepson born 1908 (about) now retired. Phillip Jepson born 1910, died in 1925 at the age of 15 from leukemia. Mary Jepson born 1915 (now Burgess) still active as Sec. of R.L. Jepson Ltd. Arnold Jepson born 1917(that's me!) Managing Director of R.L.J.

The business comprises a group as follows:- R.L.Jepson Ltd. Trading retail in furniture and carpets with what is probably the largest store of its kind in the North of England. Massey Motor Coy, Trading in engineering stores and tools. This company used to manufacture the Massey Arran Brown Motor cycle. It went bankrupt in 1925 and R.L.J. bought it from the liquidator. Nova Scotia Bearing Coy. dealing in bearings and ball-races. Jepson Finance Coy. servicing hire-puchase trade for R.L.J. Nova Scotia Transmissions Ltd. dealing in V belts, chain sprockets and pulleys etc. We bought a small company trading in Accrington selling bearings. This was the beginning of the Nova Scotia Bearing Co. which was developed by Ernest Jepson and very soon became the biggest profit earner in the group and still remains so.

Our staff normally stay with us all their working life. One has just retired on to half-time, he joined the company in 1922 at the age of 14. Incidentally one final point of interest, the grandson of my father's partner, T. Cemm is now with the business and a Director of Nova Scotia Transmissions Ltd.

I should be delighted to learn more about Marie Ortmann. I had no idea we had any relatives still alive in America. I have been over to States this year for the first time. I shall certainly go again and who knows, may well be able to have a family reunion with your member.

Although the practised family historian will detect some small inconsistencies in this story, Marie was "over the Moon" to receive the letter and soon there is to be another of those happy transatlantic family reunions. Maybe Marie will tell us all about it after the event.
