MEETINGS REPORT

At an extra meeting held on Monday 24th March we were privileged to welcome as our speaker, Councillor Bob Newton, Mayor of Derby. Councillor Newton spoke of his life as a child when he was separated from his parents on being taken to live in the workhouse when the family hit on hard times. He described in detail the terrible conditions in the workhouse at that time and spoke of the utter misery andhumiliation of those unlucky enough to be sent there. He said he never saw his mother again after they were admitted to the workhouse and she eventually died there. The happy times in his young life were when he was sent into a foster home, when for the first time for years he had a comfortable bed and someone to say "goodnight". Thankgoodness times have changed!

Meetings Report cont.

It was pleasing to have one of the Society's own members, Mr. Richard Thornton of Nettleham, Lincoln, to be the speaker at the end of March meeting. His subject was the Kerry family of SMALLEY and the Rev. Charles Kerry (1833-1908) in particular. This talented gentleman was not only a priest but also a teacher, an antiquarian, an architect; an auther, an archaeologist, a genealogist, a stained-glass manufacturer and a benefactor to the poor of Smalley.

In April the Annual General Meeting took place when officials were appointed for the ensuing year (See page 1.) Yet again we did not have time to index the Ironville 1851 census there always seems to be so much else to be fitted in to the evenings.

NOTE: A word of warning. When searching parish registers it is advisable to search them very thoroughly. In order to save on expenses, a minister sometimes squeezed entries in on pages as much as forty or fifty years away from the year the event took place. Examples of this were found in the Pentrich Registers.

I am very thrilled to have at long last got somewhere with my Bolsover COUSIN family. In October a friend and I went to London for the day to do some research and we visited Somerset House where I was to obtain COUSIN wills since 1858 (which also gave me some death dates). By the way we also popped briefly into St Catherine's and it was bedlam! I have never seen the place so crowded, I'm glad I did my research there a couple of years ago. Since the big upsurge in interest in family history the place no longer seems adequate to meet the demand. Definitely a place to avoid from now on unless one is able to get there at 8.30 a.m.

However, I digress. At Cambridge Reference Library the long awaited Mormon microfiche for the whole country arrived in November, having been on order for 18 months! I was very pleased to find that Derbyshire is well covered by the CFI and especially that they had filmed the registers for Bolsover and Eckington, the latter being where my grandfather William and his father Joseph gave as their birthplace in the 1871 Census. I was fortunate enough to find both their baptisms and marriages, and this gave me the name of Joseph's parents too. Unfortunately the marriage of this couple wasn't there, but there are Cousin entries for Eckington going back to the early 1700's, so I am hopeful of getting further back. Another surprise was that there were Cousins at Bolsover right back to the early 1600's and so I imagine the two lots were related. This would give a reason for gt. gt. grandfather Joseph's move to Bolsover sometime between 1837 and 1846.

The story does not end there. Earlier in the year I joined the Birmingham and Midland Genealogy Society to get help with the Green family of Worcestershire who intermarried with the Cousins. In their August magazine was a request for someone to do research work in Cambridge in return for work at Lichfield Record Office. As the Derbyshire wills are kept there I wrote off to the lady in question and asked her to look up my Cousin entries at Bolsover and Eckington in the Calendars. Even though she already found someone else to do her Cambridge research she extracted the relevant information for me, which was most kind. There was nothing for Eckington, but quite a few wills for Bolsover. I was then able to send for photocopies of the wills and thus learn something about these folk. They turned out to be nailers (a trade which I also believe from directory notes, to have been a speciality at Eckington) and all seemed to own their own houses and little bits of land. I hope I do turn out to be connected with these people as it will make a nice change from the generations of farmers and agricultural labourers in my other ancestral lines! Gt. gt. grandfather Joseph, by the way, was a cottage farmer at Bolsover and his wife was teacher at the Infants School, so he doesn't appear to have had an industrial trade himself.

It is all proving to be very interesting and so a priority in 1980 is a visit to Matlock, especially as the Bolsover registers have been deposited there. I keep looking for someone amongst the Derbyshire FHS members who has interests in Cambridgeshire so that I can write and offer reciprocal research, but no such luck so far. Never mind I shall get there in the end.

Hope I haven't bored you with all this stuff, it just goes to show what can be done from a distance without actually looking at the local records. I have managed to get into the 18th century with both the Cousin and Green lines without visiting either county to do research!

What an interesting story, can anyone take up Janet's offer? Let's hear some more success stories. (Editor)

A faculty measure was applied for in order to widen LONG LANE. While no memorials are affected by this, three graves had to be moved. The remains of these bodies were reinterred in the churchyard. The following schedule was on view in the church porch at the time the inscriptions were recorded.

- 1. The grave of Ada Annie WILLIAMSON, late of The Cottage, Osliston, who died on 14 June 1954. Aged 75.
- 2. A grave believed to be that of a Mr. HOLDEN, the date of whose death is not recorded.
- 3. The grave of Thomas ELEY late of St. Oswald's Hospital, Ashbourne, who was interred on 3 September 1955. Aged 78.

You mention that the ascertaining of Genealogical Descents may be of great Use: Cur Ancestors did not think so; and - - - lo ked upon this - - - to be a high Badge of Slavery, and so destructive to the Liberties of a free People that they gave excise to get rid of this Egyptian Bondage; but you say they are only now obliged to register with the Parson of the Parish: And why so? Are we to give the Priests what our Ancestors refused to the King? Why should a Dissenter register with the Priest of the Parish and not with the Minister of his own Congregation? Why should not the Jew be allowed to register with his own Priest? Why should not the Nobility be allowed to register in the Herald's Office? And as for the Descent of the Poor, what need they to register? What signifies Genealogy to poor Labourers and Manufacturers, and they are twenty to one of those to whom Genealogy may be of Use, yet all are to pay the Priest of the Parish? As for Successions: the Times when Youth comes of Age, we find that they do take Possession of their Estates, and we find few Inconveniences; and if some Disputes have arisen, a few Inconveniences can be no Objection to a general Law, since no general Law can be without a few Inconveniences.

You say that the Overseers are to return all the Males and Females in the Parish to the Justice of the Peace: How severe a Task it is for an Overseer to examine everyone from the Beggar to the Lord, in a great Parish from the sucking child to the 'decrepid' old - - - -
